FEDERAL PLUS LOAN REQUEST FORM

INSTRUCTIONS: Complete this form and return it to the Financial Aid Office if you are a parent requesting to borrow a federal PLUS loan for your child enrolled at Northwestern Connecticut Community College. Upon receipt of the completed form, the Financial Aid Office will confirm both your eligibility and that of the student to obtain a federal PLUS loan. Kindly be advised that the student must meet all student eligibility requirements for the receipt of federal title IV student financial aid. This includes the requirement that the student be fully matriculated into an associate degree or eligible credit certificate program of study at the college.

A Free Application for Federal Student Aid or FAFSA form must be completed by all students and parents applying for student financial aid including the federal PLUS loan. The college will not certify the eligibility of a student or parent to receive student aid until the FAFSA form has been processed and the results provided to the college.

Note: It is a fact that any student eligible to receive a federal PLUS loan is eligible to borrow a federal Stafford Student Loan. The terms of the Stafford Loan program are different from the terms of the PLUS program. A student need not repay the Stafford loan until after leaving college but a parent will begin repayment of the PLUS loan within 60 days of receiving the loan award. Given college costs and student eligibility for financial aid, less than one parent a year has obtained a federal PLUS loan to meet the expense of their child attending Northwestern.

Northwestern electronically initiates the PLUS loan application and certifies student and parent eligibility. Our lender is College Credit, part of The College Board Education Loan Program. The loan is serviced by SallieMae Servicing and guaranteed by the Connecticut Student Loan Foundation. SallieMae will notify you as to how you are to complete the Promissory Note for the PLUS loan.
